



MEMORANDUM OF UNDERSTANDING

BETWEEN

SALAHADDIN UNIVERSITY- ERBIL, KURDISTAN- IRAQ
AND

UNIVERSITY OF GUILAN - IRAN



Salahaddin University-Erbil (SUE, thereafter) and University of Guilan (UG) agree that the development of cooperation and exchange in all academic areas of mutual interest would be desirable. The two institutions wish to expand the basis for friendship and cooperative educational exchange; therefore, they set forth the following articles of agreement:

Article 1: The purposes of this general MOU include, but are not limited, to the following:

- 1- Faculty/students exchange
- 2- Development of collaborative research projects.
- 3- Postgraduate students joint supervisions.
- 4- Organization of joint academic and scientific activities.
- 5- Exchange of publications and other materials of common interests.

Cooperative projects under this general MOU may include any of the academic disciplines represented at either of the two institutions.

Article 2: In order to carry out and fulfill the goals of this MOU, SUE (www.su.edu.krd) and UG (www.guilan.ac.ir) University will appoint a coordinator for the development and management of joint activities. Through these contact persons, either institution may decide later only by a joint committee and approved by officials initiate proposals for activities under this MOU. Specific details of any activity will be at both universities. A letter of agreement will include such items:

- 1- Elaboration of the responsibilities of each institution for the agreed activity.
- 2- Budgets and sources of financing for each activity.

Article 3: This MOU will come into force on the date of its signature by both parts and will be valid for five years. This MOU may be amended by mutual agreement of both institutions. This MOU may be terminated by either institutions at any time provided that the terminating institutions gives written notice of intention to terminate at least six months prior to termination. However, all agreements signed before that will be remain active unless both sides of the agreement agreed upon.




